Operation Exp / Oper Repair serv - 51000 (final CNR, well 4 pump test 23000)

Total Exp - Oct was high; net income for Oct 1185;

Budget vs Actual - 101600 was based on low expect for taps; past debts

Repair Services - included RNB

Tap - Material -- move to Repair Services

Motion to roll together (tap/material and Repairs Service) - Robin; Angie will keep as is for now and get back to us next month; Angie will talk with Debra

Balance - under liabilities, look at member dues 47000 and is continually increasing; Robin - do we draw interest on this? Don't think so. Angie - we may not be allowed to do that because we are a non-profit; I'll ask about it.

Long-term liabilities with loans -- put an additional 5000 down last month and this month, aside from 750 monthly payment; around 23000 now

Transaction list by vendor - Allsay is zeroed out now, CNR final payment made, Kaboda, Lightning Water Works (Brent's) pay weekly the first month and now moving to monthly, RNB Ventures 12000 this month, Water Waste Water Services zeroed out (Pete's)

Director Report - .34% water loss

Exceptional Usage - Amy Holdage is a renter and owners blaming WB for burst pipes (taken care of), Hugo Tover 22000 gallons (leak under house discovered), Cathy Wood 23000 (still haven't found leak)

 - a. TCEQ reporting update for Well #4 Test/Mike Lucci

Well 4 upgraded; Mike needs dated reports to send to TCEQ; surveying gps'ing all our spots, what pipes to upgrade;

Have not heard back from state; no contract, only employee job description; he was never fired; TABLED for now

c. Discuss recently finished projects or other upcoming projects & on SCADA system updates

Robin - we have a controller that is needed to be flashed up new firmware, will be put in this weekend

- 7. Water Operator Report Brent
 - a. Project list update

Three leaks fixed in three weeks; replacing a bunch of valves (30+ valves are bad out of 74); now there's a complete loop to be completed so all homes are taken care of if one well has problem; Ranch and Well 5 work together for looping; zone 5 almost done; flush valve being replaced; Robin - bypass on Jonquil? Mike - it is now below ground; plugging away at valves; 19th and 20th, tanks will be serviced and cleaned inside

8. Utility Manager Report Randal

Gary called Brent about; cold sack is killed project; melina 1456 bob white is pending; still need to make decision on cul de sac;

- 9. Office Manager Report Angie
 - a. Discuss elections coming up

Election procedure timeline in paperwork; choose credentials committee (normally done at beginning of board cycle), election auditor (counts ballots at meeting; Marty has been named); from Dec 30 Angie already has the applications; January the board has to meet (Jan 31) 40 days prior to election to approve and finalize and then Angie will, within 10 days, mail out the ballots; if no one applies, then board has to pass a resolution; Angie - request the committee chair person fill in election procedures form and give to Angie; three positions open

Not final; we've applied for forgiveness but gov't keeps changing rules on time window and percent of payroll which means we have to keep resubmitting paperwork.

This is the goal; still owe 23000, so it may not happen in two months; Eliot (owner) - Mike will talk with him about pushing due date to June

14. Discuss purchase of Fire Station property

Guy Anderson - bottom line is I think the station is available; value of land "gifted" by CCMA and aerobic system → approx \$60,000; talking about this since the CCMA and Water Board split; shortly after Erv died, met with people about who would own the building and the WB has been allowed to use the building; value of land has gone up; possible tax exempt status for WB; need to make sure the money is available before making a deal; building is available for use by WB; would rather get into a contract of use; instead of a lease, I would rather do a "donation". Robin - originally deeded to fire department; they are ready to do the same with CCWSC. Mike - what is the bottom number?
